

Utility Company Special Programs

Check with your utility about any special programs such as average monthly payment plans, bill extender plans, third party notification of termination, and charitable assistance in the area. Maryland regulations require utility companies to offer low-income customers deferred payment arrangements on outstanding bills to avoid termination or maintain service.

Ask about the following utility specific programs:
